3/2/2026	Amendment to Bylaws Article 5 section 5.2: The Executive Officers will hold a regular PTO meetings at least once a month when school is in session. The Executive Officers may provide, by resolution, the time and place for the holding of additional regular meetings without other notice than such resolution. Regular PTO meetings will be open to all members of the BFA PTO except for executive sessions. The Executive Officers may also hold Executive Officer meetings as needed for planning, administrative, and governance purposes. Executive Officer meetings are not required to be publicly noticed; however, any official actions taken at such meetings will be recorded in the official minutes and reported at the next regular PTO meeting. The Executive Officers will set a schedule of regular PTO meetings for the upcoming year at the beginning of each school year.
